## Vice-President Report

#### 1. Nominating Committee

It's hard to believe that it's that time of year again where we will be forming our Nominating Committee for our 2026/27 election at our April 2026 AGM.

In accordance with our by-laws (see below), a nominating committee shall be formed:

a) At the October meeting of the Association, the Executive Board shall appoint three (3) members as a nominating committee to prepare a slate of nominees consisting of at least one (1) candidate for each Executive Board position up for re-election. This slate shall be presented at the Annual General Meeting for election of the new Executive Board. Nominations from the floor will also be accepted at the Annual General Meeting. Voting members of the nominating committee are not barred from becoming nominees for office. If more than one candidate is running for an Executive Board position, the vote shall be by secret ballot.

Positions which are up for election at the Annual General Meeting in April 2026 (even year):

- Vice-President (incumbent Carol Perrin)
- Treasurer (incumbent Joe Alleveto vacating)
- Recording Officer (incumbent Susan Wery)

We are also seeking a **Membership Coordinator immediately** to replace the fabulous Judy Huntington-Mackay who has done an amazing job over the last several years in increasing our membership numbers by encouraging and engaging all residents. This role is not an elected position, but rather appointed. Please contact me directly if you are curious about this position and/or have an interest in helping.

As usual, I am encouraging Members/Residents to get involved, whether it is with the Nominating Committee, or to put your name forward with interest in volunteering for one of our Executive Committee positions.

### 2. The Village Round Table

As the Executive liaison to the VRT, I have participated in some of the VRT meetings in 2025. As previously mentioned, this group's focus has devolved and for the last several years the focus has mostly been private / non-condo laneway management/maintenance. The committee has now been officially disbanded, and a replacement committee called SALT (Self-Administered Laneway Team) has been created. This group is not a VCA committee, but includes private laneway representatives to facilitate communication and share maintenance resources.

The VRT also had a Contact List which has now been passed along to the VCA and uploaded to our website. This list includes names of contractors and local resources to assist our residents with their needs.

### 3. Wildlife in The Village

We can hear them, but we don't often see them! We have had very few coyote sightings in the Village this past Spring and Summer. Recently, a few have been seen roaming in the early evening, but did not display any unusual behavior (following / stalking etc). We do remind residents to always be cautious when walking your pets, and to please be vigilant about keeping food sources well secured and remove bird feeders. Our VCA Website has a page dedicated to this and provides a wealth of information on what to do, what not to and who to call.
